TRADEMARK ASSIGNMENT

WHEREAS, by virtue of the Assignment dated the 28th day of May, 2005 between (A) Perfect Home, L.L.C., a limited liability company having a record address of P.O. Box 6029, 2845 Wall Triana Highway, Huntsville, Alabama 35806 (referred to hereinafter as "ASSIGNOR") and (B) RICHARD J. GROOS, an individual acting as an agent for an undisclosed principal and having a business address of 600 Congress Avenue, Suite 2400 Austin, Texas 78701 (hereinafter "AGENT"), AGENT acquired legal ownership from ASSIGNOR of the mark "PERFECT HOME" ("PERFECT HOME" and any variations thereof adopted or used by ASSIGNOR are hereinafter defined as the "MARK") including all goodwill appurtenant thereto, and United States Trademark Registration No. 1,560,988 (the "REGISTRATION") in trust for the benefit of Homer TLC, Inc. (hereinafter "Homer"), a Delaware corporation having a principal place of business at 1404 Society Drive, Claymont, Delaware 19703.



WHEREAS, Homer is the undisclosed principal and desires to acquire the legal ownership of the MARK and the REGISTRATION and the goodwill associated with the MARK;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, AGENT hereby assigns all his legal right, title and interest in and to the MARK and the REGISTRATION to Homer, including the right to enforce the MARK and

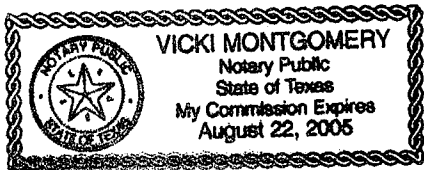
the REGISTRATION, and the right to recover for past damages for infringement thereof, together with the goodwill of the business symbolized by the MARK.
