FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, **emWare, Inc.**, a Delaware corporation (“*Assignor*”), hereby sells, assigns and transfers to **Matsushita Electric Works, Ltd.**, a joint stock company incorporated in Japan, and its successors, assigns, and legal representatives (“*Assignee*”), *nunc pro tunc*, effective as of June 1, 2005, pursuant to the terms of that Asset Purchase Agreement between Assignor and Assignee, dated May 11, 2005, all of its right, title and interest, together with the goodwill of Assignor’s business associated therewith, for the United States and all foreign countries, in and to:

Assignor agrees to execute and deliver at the request of Assignee all papers, instruments, and assignments, and to perform other reasonable acts Assignee may request in order to vest all right, title, and interest in and to the Trademarks over to Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Assignee, to the extent such evidence is in the possession or control of Assignor.


