PATENT APPLICATION AND TRADEMARK ASSIGNMENT AGREEMENT

THIS PATENT APPLICATION AND TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement"), dated as of June 30, 2005, by and between InsBridge, Inc., a Delaware corporation ("InsBridge"), and Skywire InsBridge, LLC, a Texas limited liability company ("Skywire InsBridge").

Recitals

WHEREAS, pursuant to an Asset Purchase Agreement (the "Asset Purchase Agreement"), dated effective as of June 4, 2005, by and between Skywire InsBridge, InsBridge, and Segre Software, Inc., a Texas corporation ("Segre"), InsBridge and Segre have sold substantially all of their assets to Skywire InsBridge;

WHEREAS, InsBridge has filed and is owner of the United States patent application shown on the attached Schedule A (the "Patent Application");

WHEREAS, InsBridge has adopted and used the mark INSBRIDGE for computer software for use by insurance companies and agents to quote, rate, submit and store application data, and is owner of the United States trademark shown on the attached Schedule B (the "Mark"); and

WHEREAS, Skywire InsBridge desires to acquire all right, title, and interest in and to the Patent Application and the Mark and all goodwill and other rights related thereto;

NOW, THEREFORE, in consideration of the promises and the mutual agreements, covenants, and provisions contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. InsBridge does hereby sell, assign, and transfer to Skywire InsBridge, its successors and assigns, all right, title, and interest in and to the Patent Application and any divisions or continuations thereof, and the inventions therein disclosed, and improvements thereon, and any patent or patents that may be issued or reissued thereon.

2. InsBridge does hereby sell, assign, and transfer to Skywire InsBridge, its successors and assigns, all right, title, and interest in and to the Mark, together with the business, or portion thereof, to which the Mark pertains and the goodwill of the business symbolized by the Mark, as well as the entire right, title, and interest in and to all applications for and registrations of the Mark heretofore granted or applied for, as well as any and all common law rights in and to the Mark in the United States and in any state thereof and in any country in the world, and any and all claims and demands InsBridge may have either at law or in equity arising out of any past infringements of the Mark.

3. InsBridge does hereby expressly agree that Skywire InsBridge may singly, and without assistance or consent from InsBridge, undertake procedures to record the transfer of the Patent Application and the Mark to Skywire InsBridge with the United States Patent and

Trademark Office or other applicable agency or governmental entity and to terminate any powers of attorney previously granted by InsBridge with respect to the Patent Application and/or the Mark (including but not limited to powers of attorney granted to Andrews Kurth L.L.P. with respect to the Patent Application and Hughes & Luce, LLP with respect to the Mark). InsBridge hereby expressly covenants and agrees that it will promptly cooperate with and assist Skywire InsBridge in taking the actions set forth in this paragraph to the extent reasonably requested by Skywire InsBridge.

4. Schedules A and B are incorporated herein by reference.
