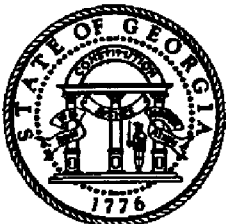

ARTICLES OF AMENDMENT
of
ITM INC.

1. The name of the corporation is ITM Inc.
2. The Articles of Incorporation have been amended as follows:
 - 2.1 FIRST -- The name of the corporation is: In Touch Ministries.
 - 2.2 The following amendment to paragraphs in section "FOURTH."
 - (b) to produce and publish Christian literature of all types and in all appropriate formats; and as appropriate, to establish, own, and operate one or more printing plants or publishing houses for the publication and distribution of such literature.
 - (c) to produce and distribute Christian programs on films, tapes, slides, discs, and other audio, electronic, and visual media now existing or hereafter developed suitable for personal communication, and/or broadcasting;
 - (g) to establish or assist in establishing, both domestic and international affiliates or separate organizations to carry out the mission and goals of the Corporation.
 - 2.3 All references in Articles to "Internal Revenue Code of 1954" should be amended to read: "Internal Revenue Code of 1986."
3. The above amendment was adopted on Oct. 5, 1993.
4. The corporation has no members and therefore no membership vote was required. The amendment was adopted by a unanimous vote of the board of directors.
