The foregoing Amendment was approved by the required vote of the shareholders of said corporation in accordance with Section 902 of the California General Corporations Law; the total number of outstanding shares of each class entitled to vote with respect to the foregoing Amendment was 216,444 shares, and the number of shares voting in favor of the foregoing Amendment was 213,244 shares. Holders of shares exceeding the minimum number of votes required to consent to said Amendment approved of said Amendment. The percentage vote required was more than fifty percent (50%).

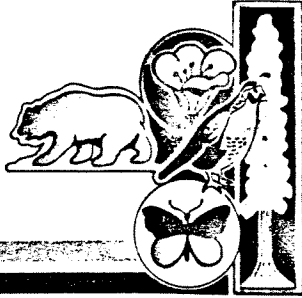
