## RELEASE OF TRADEMARK SECURITY

This Release of Trademark Security is made as of the 6<sup>th</sup> day of April, 2005 (the "Payoff Date"), by and between Crystal Rock LLC, a Delaware limited liability company with offices at 1050 Buckingham Street, Watertown, CT 06795 ("Debtor") and Webster Bank, National Association, a national banking association, as Agent, with an office at 145 Bank Street, Waterbury, Connecticut 06702 ("Secured Party").

WHEREAS, Debtor, Vermont Pure Holdings, Ltd., a Delaware corporation ("Vermont") and Secured Party entered into an Amended and Restated Loan and Security Agreement dated as of December 30, 2004 (the "Security Agreement").

WHEREAS, Debtor and Secured Party entered into an Amended and Restated Trademark Security Agreement dated as of December 30, 2004 (the "Trademark Security Agreement") pursuant to which an Amended and Restated Security Interest in Trademarks was recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 003009/0054.

WHEREAS, the Debtor and Vermont have repaid the obligations owed to Secured Party under the Security Agreement and as of the Payoff Date Secured Party has terminated, released and discharged its security interest in all the Trademarks listed on Schedule A.

WHEREAS, Debtor, Vermont and Secured Party wish to record in the U.S. Patent and Trademark Office such termination, release and discharge.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtor and Secured Party hereby agree as follows:

As of the Payoff Date, all of Secured Party's security interests, liens, pledges, mortgages, and other encumbrances of any kind whatsoever created pursuant to the Security Agreement and the Trademark Security Agreement (collectively, the "Security Interests") are automatically terminated, released and discharged, and the Secured Party hereby authorizes Debtor to file any such documents, including filings with the U.S. Patent and Trademark Office against the trademarks listed in Schedule A hereto, as shall be necessary to effect the termination, release and discharge of all of the Security Interests.

This Release may be executed in any number of counterparts, but all of such counterparts shall together constitute one and the same instrument. This Release shall be governed and construed in accordance with the laws of the State of Connecticut, without regard to the principles thereof relating to conflict of laws.

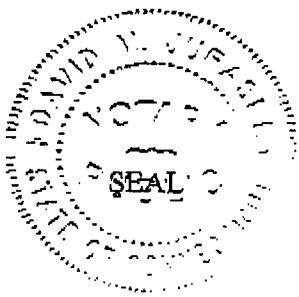
