RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARK

This Release of Collateral Assignment of Trademark is made as of the 6th day of April, 2005 (the "Payoff Date"), by and between Vermont Pure Holdings, Ltd., a Delaware corporation with offices now or formerly at 45 Krupp Drive, Williston, Vermont 05495, 70 West Red Oak Lane, White Plains, New York 10604 and Catamount Industrial Park, Route 66, Randolph, Vermont 05060 ("Vermont") and Webster Bank, National Association, a national banking association (f/k/a Webster Bank, a federally chartered savings bank), as Agent, with an office at 145 Bank Street, Waterbury, Connecticut 06702 ("Webster").

WHEREAS, Vermont, Crystal Rock Spring Water Company, a Connecticut corporation ("Crystal"), Vermont Pure Springs, Inc., a Delaware corporation ("Vermont Inc.") and Webster entered into a Loan and Security Agreement dated as of March 5, 2003 (the "Security Agreement").

WHEREAS, Vermont, Crystal, Vermont Inc. and Webster entered into a Trademark Collateral Assignment and Security Agreement and Assignment for Security dated as of March 5, 2003 (the "Trademark Security Agreement") which has been recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 002700/0147, against the trademarks listed in Schedule A hereto and pursuant to which Vermont granted to Webster an assignment of the trademarks listed in Schedule A subject to and effective upon the occurrence of a default (the "Collateral Assignment").

WHEREAS, Vermont and Webster entered into an Addendum to Trademark Security Agreement dated as of March 5, 2003 (the "Addendum") which has been recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 002869/0969, against the trademarks listed in Schedule A hereto.

WHEREAS, Vermont and Crystal Rock LLC, a Delaware limited liability company ("Crystal Rock LLC") entered into an Assignment of Trademarks dated as of December 30, 2004 which has been recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 003008/0957 and Crystal Rock LLC and Webster entered into an Amended and Restated Trademark Security Agreement dated as of December 30, 2004 pursuant to which an Amended and Restated Security Interest in Trademarks was recorded by the Trademark Assignment Division of the U.S. Patent and Trademark Office, Reel/Frame 003009/0054.

WHEREAS, Vermont, Crystal, Crystal Rock LLC and Vermont Inc. have repaid the obligations owed to Webster under the Security Agreement and to the extent that the Collateral Assignment took effect at any time, and in any case for the avoidance of doubt, Webster has assigned back to Vermont the trademarks listed on Schedule A and terminated and released the right to the Collateral Assignment.

WHEREAS, Vermont, Crystal, Crystal Rock LLC, Vermont Inc. and Webster wish to record in the U.S. Patent and Trademark Office such assignment, termination and release.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Vermont and Webster hereby agree as follows:

As of the Payoff Date, all right title and interest in and to the trademarks listed on Schedule A were assigned by Webster back to Vermont (and assigned by Vermont to Crystal Rock LLC as Vermont's successor in interest to the trademarks listed on Schedule A) and the right to the Collateral Assignment granted by Vermont to Webster was automatically terminated and released. Webster hereby authorizes Vermont or Crystal Rock LLC to file any such documents, including filings with the U.S. Patent and Trademark Office, as shall be necessary to effect the assignment and release.

This Release may be executed in any number of counterparts, but all of such counterparts shall together constitute one and the same instrument. This Release shall be governed and construed in accordance with the laws of the State of Connecticut, without regard to the principles thereof relating to conflict of laws.
