ASSIGNMENT AGREEMENT

THIS ASSIGNMENT is made the 2nd day of August, 2005.

Between

International SOS Assistance, Inc., a Company incorporated in the State of Delaware, USA, with a place of business at 8 Neshaminy Interplex, Suite 207, Trevose, PA 19063-6095, U.S.A., (hereafter referred to as the "Assignors") of the one part

- (1) For good and valuable consideration, receipt of which is hereby acknowledged by the Assignors, the Assignors as beneficial owner assign to the Assignees absolutely all rights, title and interest in and to the Trade Mark, including without limitation, the whole of the goodwill of the business of the Assignors concerning the goods/services for which the Trade Mark is registered **TO HOLD USE EXERCISE AND ENJOY** the Trade Mark
- (2) This Assignment includes all rights and benefits relating to the Trade Mark including, without limitation, the right of the Assignee to bring action and claim relief in respect of any infringement or unauthorised use of the Trade Mark whether occurring before, on or after the date of this Assignment.
- (3) The Assignors covenant, at the direction of the Assignees, to execute all such documents, forms and authorisations and depose to or swear any declaration or oath as may be required for absolutely vesting full right title and interest to the Trade Mark in favour of the Assignees.
- (4) This Agreement may be executed in any number of counterparts. All counterparts together will be taken to constitute one instrument.
