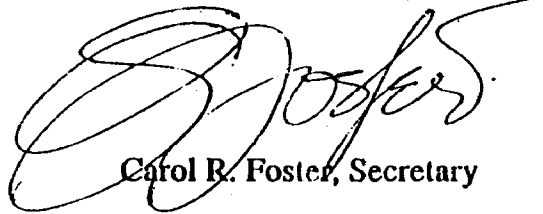
**MINUTES OF MEETING
