- 1. Article I is amended to read as follows:

The name of the corporation is "GenuTec Business Solutions, Inc."


- 2. The above-stated amendment was adopted by the shareholders on May 22, 2000.

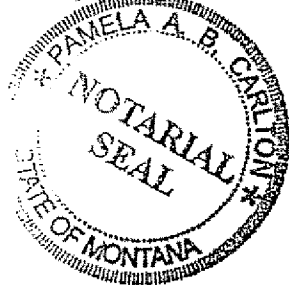

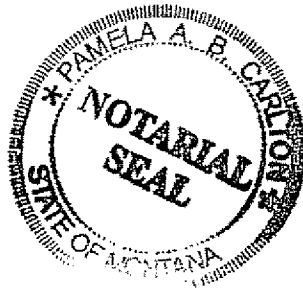
