THIS DEED OF ASSIGNMENT is made and delivered the 21st day of March 2005

BETWEEN:

- (1) Promethean Ltd, a company incorporated under the laws of England and Wales and having its principal place of business at TDS House, Lower Philips Road, Blackburn, Lancashire, BB1 5TH (which company is hereinafter referred to as the "Assignor");
and
- (2) Promethean Technologies Group Ltd, a company incorporated under the laws of England and Wales and having its principal place of business at TDS House, Lower Philips Road, Blackburn, Lancashire, BB1 5TH (which company is hereinafter referred to as the "Assignee").

WHEREAS:

1. The Assignor is the proprietor around the world of certain trade marks.
2. The Assignor is prepared to assign the legal and beneficial ownership of certain trade marks to the Assignee for the consideration hereinafter mentioned and consents to their usage by the Assignee.

NOW THIS DEED WITNESSETH as follows:

1. In this deed the following expression shall have the following meaning: "Trade Marks" means the marks set out in Schedule 1.
2. In consideration of the payment of the sum of £1.00 [one pound sterling] paid by the Assignee to the Assignor (receipt of which is acknowledged) the Assignor hereby

assigns to the Assignee with full title guarantee all property rights usage title and interest in the Trade Marks, together with all and any common law rights connected therewith, together with all accrued rights to sue in respect of infringements, together with the goodwill and interest of the Assignor in and concerning the business relating to the goods/services in respect of which the Trade Marks have been registered and used relating to the Trade Marks, together with the business pertaining to the Trade Marks, TO HOLD unto the Assignee absolutely, to the intent that upon registration of this Deed the Assignee shall be entered as the registered proprietor of the Trade Marks.

3. The Assignor shall at the request of the Assignee at all times after the date of this Deed do all such acts and execute all such documents as may from time to time be necessary or desirable to secure the vesting in the Assignee of the Trade Marks and all rights assigned to the Assignee under this Deed.
4. This Deed shall be governed by and construed in accordance with the laws of England and Wales and the parties hereby irrevocably submit to the exclusive jurisdiction of the English Courts in relation to this Deed and its subject matter.


