## ASSIGNMENT

This Agreement is made by and between IB-US Stone Limited Partnership ("Assignor") an Ohio limited partnership, having a place of business at 14777 Chrisman Road, Houston, Texas 77039 and Block Stone Enterprises, L.P. ("Assignee"), a Texas limited partnership, having a place of business at 14777 Chrisman Road, Houston, Texas 77039. By this Agreement, Assignor and Assignee agree as follows:

WHEREAS Assignor is the sole owner of the trademark "AVANZA" for use in connection with engineered stone and related services and U.S. Federal Trademark Registration No. 2,724,548 for the mark AVANZA for engineered stone (collectively the "AVANZA Trademark");

WHEREAS Assignor desires to assign all rights, title, and interest in and to the AVANZA Trademark to Assignee;

WHEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to it in hand paid, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby sells, assigns, transfers, and conveys to Assignee, its successors and assigns, Assignor's entire right, title, and interest in and to all common law rights, rights of priority, and goodwill associated with the term AVANZA, including but not limited to the AVANZA Trademark. Assignor further sells, assigns, transfers, and conveys to Assignee, its successors and assigns, Assignor's entire right, title, and interest in and to any and all rights and causes of action (including damages recoverable thereby) for past, present, and future unauthorized use of the term AVANZA and/or the AVANZA Trademark, including but not limited to all rights and causes of action for infringement and unfair competition.

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and enforce full the benefits of the rights and interests herein sold, assigned, transferred, and conveyed. This Agreement shall be binding on the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee.

Assignor represents and warrants that it owns all right, title, and interest in and to the term AVANZA and the AVANZA Trademark, that it has the authority to transfer all of the rights sold, assigned, transferred, and conveyed pursuant to this Agreement, and that it has not licensed anyone to use the term AVANZA and/or the AVANZA Trademark in any way.


