ARTICLES OF AMENDMENT

BY THE BOARD OF DIRECTORS TO THE *Corporations Section*
ARTICLES OF INCORPORATION OF

M.C.E. SYSTEMS CORP.

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation, which changes the name of the corporation from M.C.E. SYSTEMS CORP. to QUIKSERV CORP.

ARTICLE I

The name of the corporation is M.C.E. SYSTEMS CORP.

ARTICLE II

The following amendment to the Articles of Incorporation was adopted by the Shareholders of the corporation on January 21, 2000.

Article I of the Articles of Incorporation is hereby amended so as to read as follows:
The name of the corporation is QUIKSERV CORP.

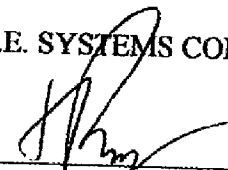
ARTICLE III
