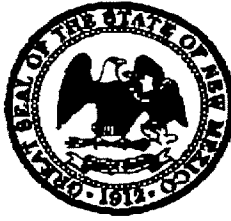

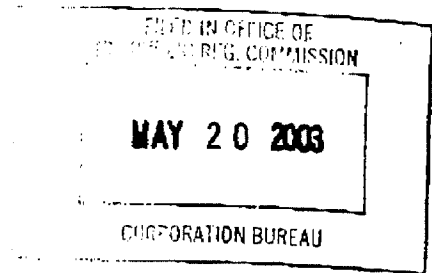

NAME

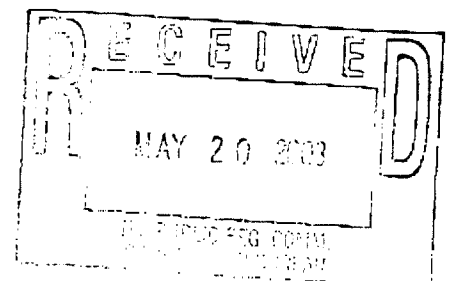
