**ORDER APPROVING CHAPTER 7 TRUSTEE'S  
SALE AND/OR ASSIGNMENT OF DE MINIMIS ASSETS**

This matter having been presented to the Court by Montague S. Claybrook (the "Trustee"), Chapter 7 Trustee for the estate of Breuners Home Furnishings Corp., *et al.* (the "Debtors") for the entry of an order approving the sale and/or assignment of certain de minimis assets (the "Sale") pursuant to 11 U.S.C. § 363 and Court approved procedures; and the Court having determined that adequate notice of the Sale has been given pursuant to 11 U.S.C. § 363, Fed. R. Bankr. P. 2002 and the Court approved procedures; and the Court having determined after due deliberation and sufficient cause appearing therefore:

It is hereby ORDERED that:

1. In accordance with the Order of this Court entered on May 6, 2005 [Docket No. 1032] and the terms agreed upon by the Trustee and the respective purchaser, the Trustee be and is hereby authorized, empowered and directed, pursuant to 11 U.S.C. §§ 105 and 363(b), (f) and (m) to sell the following assets (the "Assets") free and clear of any and all liens, claims, encumbrances and interests:
