## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") made as of the 3<sup>rd</sup> day of November, 2005, by and between Plastisonics, Incorporated, an Illinois corporation ("Assignor"), and Illinois Tool Works Inc., a Delaware corporation ("Assignee");

### WITNESSETH:

A. Assignor is the owner of the trademark and any and all trade dress associated therewith (the "Mark") as more fully described in Exhibit A attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby.

B. Assignor desires to convey, transfer, assign, deliver, and contribute to Assignee all of its right, title, and interest in and to the Mark.

NOW, THEREFORE, Assignor and Assignee, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

### Assignment

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's right, title, and interest in and to the Mark, together with (1) the goodwill of the business relating in respect of which the Mark used and for which they are registered; (2) all income, royalties and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark.

Assignor further conveys, transfers, assigns, delivers, and contributes to Assignee all rights in the trade dress, labels, and designs associated with the Mark.

### Further Assurances

Assignor further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Mark.
