Intersil hereby further acknowledges and confirms that Intersil assigned to Globespan all claims, demands and causes of action for the past infringement of the Trademark Property, including the right to collect damages for past infringement, or for unfair competition in business in connection therewith wheresoever or by whomsoever committed, the same to be held and enjoyed by Globespan, and Globespan's subsidiaries, affiliates, successors and assigns, as fully and entirely as the same would or could have been held and enjoyed by Intersil had the Assignment not been made;

Globespan formally declares to accept all right, title and interest in and to the Trademark Property.

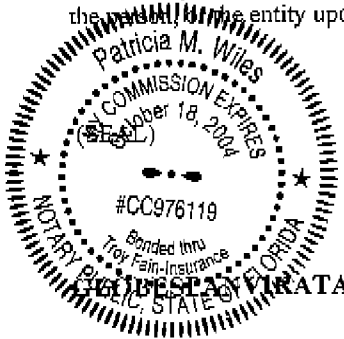
