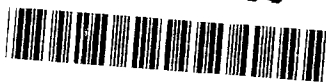


ASSIGNMENT


