## TRADE-MARK ASSIGNMENT

**THIS TRADE-MARK ASSIGNMENT** (the "Assignment") is made and entered into as of November 14, 2005 (the "Effective Date") by and between Quebecor World Inc., having its principal place of business at 612, rue Saint-Jacques, Montreal, Quebec, H3C 4M8 ("Assignor") and Grafikom Limited Partnership, with its principal office at 180 Bond Avenue, Toronto, Ontario, M3B 2P3 ("Assignee").

The Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor all rights at common law and all rights under statute in and to the trade-marks listed in Schedule "A", together with the goodwill of the business associated therewith (collectively, the "Marks").

**NOW THEREFORE** for good and valuable consideration in the amount of CAD\$1.00, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee the entire right, title and interest in and to the Marks, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of Canada and/or the United States, as applicable, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the Registrar of Trade-marks in Canada and the United States Patent and Trademarks Office in the United States to record Assignee as the assignee and owner of the Marks.


Assignor will, at Assignee's expense, take all further actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such cooperation and

assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimen, assignments, powers of attorney or other documentation), reasonably requested by Assignee to more fully and effectively carry out the purposes of this Assignment, including, without limitations, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (2) the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Marks and this Assignment; (3) obtaining any additional trademark protection relating to rights assigned herein that Assignee reasonably may deem appropriate that may be secured under the laws now or hereafter in effect in Canada and/or the United States, as applicable; and (4) in the implementation or perfection of this Assignment.


Assignee hereby appoints Torys LLP, with offices in Canada at Suite 3000, 79 Wellington Street West, Toronto, Ontario, M5K 1N2 and in the United States at 237 Park Avenue, New York, New York 10017-3142, as its agent and representative for service with respect to these Marks in Canada and the United States.
