A.W. Faber-Castell GmbH with domicile at Nuremberg for the present notarization is acting on behalf of

Kommanditgesellschaft (limited partnership) in A.W. Faber-Castell GmbH & Co. with domicile at Stein,  
in her capacity as the company's sole personally liable partner.

Certificates on the respective powers of representation shall be given separately.

On request and after instruction on the contents of the Land Register I notarize the following declarations which have been made in mutual presence:

- hereinafter referred to as the „vendor“ -  
hereby contributes

- c) for exclusive ownership the industrial property rights as defined under I. 3) above, i.e. her rights in trademarks, service marks, logos and appearance of goods, whether entered or not,  
– hereinafter referred to as the „subject matter of contribution“ –  
to Kommanditgesellschaft in A.W. Faber-Castell GmbH & Co.  
with domicile at Stein.  
- hereinafter referred to as the „acquirer“ or the „partnership“.

- 3) Finally, A.W. Faber-Castell Unternehmensverwaltung GmbH & Co. with domicile at Stein transfers her industrial property rights as defined under I. 3) above, i.e. her rights in trademarks, service marks, logos and appearance of goods to the full extent to Kommanditgesellschaft in A.W. Faber-Castell GmbH & Co. with domicile at Stein.  
The latter accepts the transfer.

With respect to the industrial property rights transferred liability shall be limited to the extent that they are free of rights of third parties.
