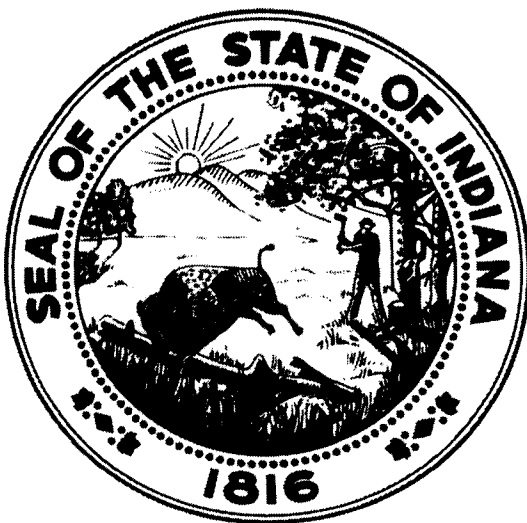

1. **NAME.** The name of the corporation prior to the filing of these Articles of Amendment was TWINLODE CORPORATION (the "Corporation"), an Indiana corporation which was formerly known as Hartman Holdings, Inc. formed on January 9, 1995.

2. **THE AMENDMENT.** Article I of the Articles of Incorporation of the Corporation is amended and restated in its entirety to read:

Article I - Name

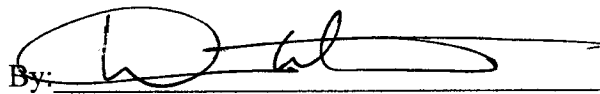
Name of Corporation: J&D GLOBAL, LTD.
