


TRADEMARK ASSIGNMENT

This Assignment is entered into pursuant to that certain Stock Purchase Agreement dated as of April 19, 2005 between the parties (the "Purchase Agreement"). In consideration of good and valuable consideration as set forth in said Purchase Agreement, the receipt and sufficiency of which the parties hereby acknowledge, it is hereby agreed as follows:


1. Assignor hereby assigns, conveys, transfers and delivers to Assignee all of Assignor's right, title and interest in and to U.S. Trademark Registration No. 1,925,140 for DATATRAC (the "Assigned Mark"), together with the goodwill of the business pertaining thereto, and the right to sue and recover damages for any and all past, present or future infringements of the Assigned Mark.
