## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "**Agreement**") is effective as of June 14, 2004, by and between FastBucks of Idaho, Inc., a Idaho corporation, FastBucks of Utah, Inc., a Utah corporation, FastBucks of Washington, Inc., a Washington corporation (collectively, the "**Grantor**"), and FastBucks Holding Corporation, a Nevada corporation ("**Grantee**").

WHEREAS, Grantor is the owner of the trademarks WIRE TO ME, including U.S. Trademark Serial No. 78/269,136 therefor; PAYDAY ADVANCES, including U.S. Trademark Registration No. 2,243,154 therefor; and CASH MAN, including U.S. Trademark Registration No. 2,352,380 therefor (the "**Trademarks**");


WHEREAS, Grantee is desirous of acquiring the Trademarks and Grantor is willing to assign them to Grantee pursuant to the terms of this Agreement.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follow:


1. **Assignment.** Grantor hereby assigns, transfers and conveys to Grantee all of Grantor's right, title and interest in and to the Trademarks, in the United States and elsewhere, including the right to sue for past infringement, together with the goodwill of the business symbolized by the Trademarks.

2. **Binding Effect.** This Agreement, and all the terms and provisions hereof, shall be binding upon and shall inure to the benefit of the parties, and their respective successors and assigns.
