TRADEMARK ASSIGNMENT

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, **SGS Société Générale de Surveillance SA**, a corporation duly organized and existing under the laws of the Switzerland, and having a place of business at 1 Place des Alpes, 1201 Geneva, Switzerland, (hereinafter "ASSIGNOR"), has adopted, and has intended to use the trademark **SGS DIGITR@DE** in commerce and has filed an application, now assigned Serial No. 78/338,904, indicating that intention, but has not yet filed an allegation of use under §§1(c) or 1(d) of The Trademark Act; and

WHEREAS, **SGS Société Générale de Surveillance IP SA.**, a corporation duly organized and existing under the laws of Switzerland, and having a place of business at Chemin des Avouillons 30, 1196 Gland, Switzerland, (hereinafter "ASSIGNEE"), acquired pursuant to that certain Contract for the Transfer of Assets by and between ASSIGNOR and ASSIGNEE, effective as of January 1, 2005, all right, title and interest in and to the trademarks, service marks, certification marks and other marks of ASSIGNOR, including, without limitation, the trademark **SGS DIGITR@DE** and application Serial No. 78/338,904, the other marks identified on the list appended to said agreement, all of the rights of said marks, and all of the business and good will represented and symbolized by said marks, and desires now to record in the United States Patent and Trademark Office its said acquisition and ownership of said trademark **SGS DIGITR@DE** and application Serial No. 78/338,904;

NOW, THEREFORE, IT IS HEREBY AGREED:

1. In consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to it in hand paid, the receipt of which is hereby acknowledged, ASSIGNOR does hereby assign and transfer unto ASSIGNEE, effective as of January 1, 2005, the entire right, title and interest in and to the said Trademark, together with the good will of the business symbolized by the mark, that portion of the ongoing and existing business of ASSIGNOR to which the mark pertains, as required by 15 U.S.C. §1060, and the above-identified application to register same.

2. ASSIGNOR shall do all acts and execute all documents which may be reasonably required by ASSIGNEE in order to effect the assignment of the Trademark and to ensure that the registration be granted to ASSIGNEE.

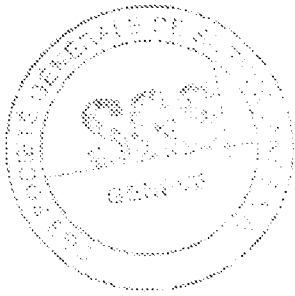

