

United States Trademark and Service Mark Assignment

Freddie Mac covenants that Freddie Mac is the owner of the Marks and the holder of record title to the Registrations and the Applications, that Freddie Mac has full power to make this Assignment and that Freddie Mac agrees to execute such further assignments and related documents with respect to the Marks, the Goodwill, and the Registrations as CSC shall reasonably request.
