**TRADEMARK ASSIGNMENT**

WHEREAS, Pfizer Inc. ("Assignor"), a company organized and existing under the laws of Delaware, with a place of business at 235 East 42nd Street, New York, New York, 10017, is the owner of the OPORIA trademark in the United States, which mark has been registered by Pfizer Inc. in the United States Patent and Trademark Office as Registration No. 2,791,799, issued December 9, 2003.

WHEREAS, C.P. Pharmaceuticals International C.V. ("Assignee"), a limited partnership (commanditaire vennootschap) organized under the laws of the Netherlands, having its registered seat in Rotterdam, and registered at the trade register held by the Chamber of Commerce in Rotterdam, the Netherlands, under number 24280998, duly represented by and acting through its general partners Pfizer Manufacturing LLC, a limited liability company organized under the laws of the State of Delaware, and Pfizer Production LLC, a limited liability company organized under the laws of the State of Delaware, with Assignee having a correspondence address at 235 East 42nd Street, New York, New York 10017, USA, desires to acquire the rights and goodwill associated with the OPORIA mark in the United States, including Puerto Rico, as owned by Pfizer Inc.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby transfers, releases and assigns to Assignee, effective as of the date signed below, all right, title and interest in and to the OPORIA mark, together with (1) the goodwill of the business symbolized by this mark in the United States and Puerto Rico, (2) U.S. Registration No. 2,791,799 for the OPORIA mark, (3) all common law rights in the mark, (4) the right of priority and (5) all claims for damages by reason of past infringement of the mark and of Registration No. 2,791,799, with the right to sue for and collect
