## ASSIGNMENT OF TRADEMARK

**ASSIGNOR** covenants and warrants that **ASSIGNOR**:


1. is the sole and lawful owner at the time of execution and delivery of this Assignment of the entire right, title and interest assigned;
2. had full right to convey the entire right, title and interest assigned free and clear of all licensees, encumbrances and liens whatsoever;
3. has not executed and will not execute any instruments in conflict herewith;
4. has lawfully and continuously used the mark of the '022 Application in commerce in the United States from at least as early as May 1, 2005 through the execution date of this Agreement;
5. never agreed to or otherwise acquiesced in the use by a third party of any mark which is identical or confusingly similar to the mark of the '022 Application for any goods recited in the Identification of Goods therein, and is not aware of any agreement or acquiescence by any predecessors in title;

6. has not suffered any adverse decisions respecting **ASSIGNOR'S** claim of ownership of the mark of the '022 Application, or to **ASSIGNOR'S** right to register the mark of the '022 Application or to maintain same on the register; and that no proceedings involving any of said rights are pending and not finally disposed of either in the Patent and Trademark Office or in any court;
7. will claim no rights contrary to **ASSIGNEE's** rights in and to the mark of the '022 Application, and that hereafter **ASSIGNOR** will not use in the United States or elsewhere in the world the mark of the '022 Application or any variant or simulation thereof, or any mark, name, logo, character, design, likeness or representation which is confusingly similar thereto, in **ASSIGNOR'S** own name or in the name of any other person or entity;
8. and **ASSIGNOR'S** successors, legal representatives and assigns shall be bound by this Agreement, which inures solely to the benefit of **ASSIGNEE** and **ASSIGNEE's** successors, legal representatives and assigns; and
9. grants William A. Bonk, III or an attorney of record the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
