## ASSIGNMENT OF TRADEMARK

WHEREAS, Bentz Mobile Products, Inc., an Indiana corporation having a business at 5620 Industrial Road, Fort Wayne, Indiana 46825 (hereinafter BENTZ MOBILE), did adopt and use the trademark BENTZ, said trademark having been registered in the U.S. Patent and Trademark Office on November 21, 2000 as Registration No. 2,405,038 (hereinafter the trademark and registration collectively referred to as BENTZ Registration);

WHEREAS, Novae Corporation, an Indiana corporation having a place of business at One Novae Parkway, Markle, Indiana 46770 (hereinafter NOVAE), is desirous of acquiring said BENTZ Registration.

NOW THEREFORE, OSSIAN BANK hereby acknowledges, represents and warrants that it did rightfully take possession of and had the right to sell the BENTZ Registration and did sell the exclusive right, title and interest in the Bentz Registration and goodwill associated therewith to MIDWEST SCRAP; and,

MIDWEST SCRAP hereby acknowledges, represents and warrants that it has the exclusive right, title and interest in and to the BENTZ Registration and, in consideration of the sum of \$10 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, MIDWEST SCRAP hereby sells and assigns to NOVAE all of its rights, title and interest in and to said BENTZ Registration, together with the goodwill associated therewith.

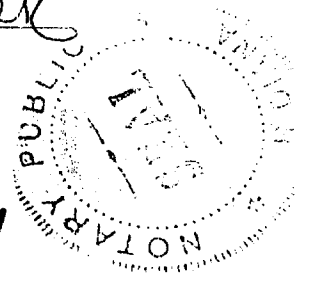
