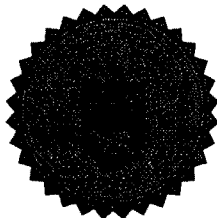

Pursuant to Section 253 of the General Corporations Law of Delaware

Juniper Networks, Inc. ("Juniper"), a corporation organized and existing under and by virtue of the Delaware General Corporation Law, does hereby certify:

FIRST: Juniper is a business corporation incorporated in the State of Delaware on September 10, 1997.

SECOND: Juniper owns 100% of the outstanding shares of the capital stock of Peribit Networks, Inc., a California corporation ("Peribit").

THIRD: The laws of each of the States of Delaware and California permit the merger of a business corporation of such jurisdiction with a business corporation of another jurisdiction.

FOURTH: The Board of Directors of Juniper, at a meeting of the Board of Directors held on December 16, 2005, authorized the merger of Peribit with and into Juniper (the "Peribit Merger") and did adopt the following resolutions:


FURTHER RESOLVED, that the Corporation merge into itself Peribit and assume all of the liabilities and obligations of each of Peribit pursuant to Section 1110 of the California Corporations Code and Section 253 of the Delaware General Corporation Law.

FURTHER RESOLVED, that the officers of the Corporation be and they hereby are authorized and directed to make and execute, with respect to the Peribit Merger, a certificate of ownership pursuant to Section 253 of the Delaware General Corporation Law, and to file the same in the office of the Secretary of State of Delaware

FURTHER RESOLVED, that the officers of the Corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware; which may be in any way necessary or proper to effect the Peribit Merger.
