## ASSIGNMENT OF TRADEMARK

Assignor hereby authorizes Assignee, at Assignee's expense, to request the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Marks and the registrations thereof shown on Exhibit A. As the owner of the Marks, Assignee shall have the sole responsibility for all future maintenance actions regarding the registration of the Marks.

3. Further Assurances. At any time and from time to time and on and after the date of this Assignment, Assignor shall, at the request of the Assignee, (i) execute and deliver to Assignee such documents and (ii) take or cause to be taken such actions, as Assignee may reasonably deem necessary or desirable for Assignee to obtain the full benefits of this Assignment and the transactions contemplated hereby.
