
Now, Therefore,

And, COMPANY, hereby authorizes and requests the Commissioner of Patents and Trademarks, to issue any registration on said Trademark to LPL as assignee of the entire interest, and hereby covenants that COMPANY has full right to convey the entire interest herein assigned, and that, except as otherwise provided between the parties, COMPANY has not executed, and will not execute, any agreements in conflict therewith.

In Witness Whereof, the parties, by their duly authorized representatives, have executed this Assignment.


