The undersigned certifies that:

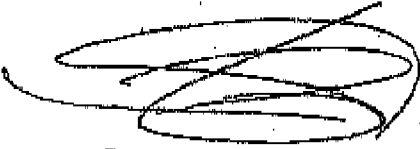
1. They are the Chairman of the Board and the Secretary, respectively, of VDI Media, a California corporation.
