**CERTIFICATE OF OWNERSHIP AND MERGER**

**(PURSUANT TO SECTION 253 OF THE GENERAL CORPORATION LAW OF THE STATE OF DELAWARE)**

FORE Systems, Inc., a corporation organized and existing under the laws of the State of Delaware (the "Corporation"),

**DOES HEREBY CERTIFY:**

**FIRST:** That this Corporation was incorporated on the twenty-fourth day of November, 1992, pursuant to the General Corporation Law of the State of Delaware.

**SECOND:** That this Corporation owns all of the outstanding shares of the capital stock of Marconi Communications Inc., a corporation incorporated on the twenty-second day of December, 1986, pursuant to the General Corporation Law of the State of Delaware;

**THIRD:** That this Corporation, by the following resolutions of its Board of Directors, duly adopted by the written consent of its members, filed with the minutes of the Board, on the twenty-eighth day of March, 2001, determined to and did merge into

itself said Marconi Communications Inc., with the Corporation surviving said merger.

**\*RESOLVED:** That FORE Systems, Inc. merge and it hereby does merge into itself said Marconi Communications Inc. and assume all of its liabilities and obligations.

**FURTHER RESOLVED:** That the merger shall be effective on April 1, 2001 at 12:02 a.m., Eastern Standard Time (the "Effective Time").

**FURTHER RESOLVED:** That any officer of this Corporation be, and each of them hereby is, directed to make and execute a Certificate of Ownership and Merger setting forth a copy of the resolutions to merge said Marconi Communications Inc. and assume its liabilities and obligations, and the date of adoption thereof, and to cause the same to be filed with the Secretary of State of Delaware and to do all acts and things whatsoever, whether within or without the State of Delaware, which may be necessary or proper to effect said merger.

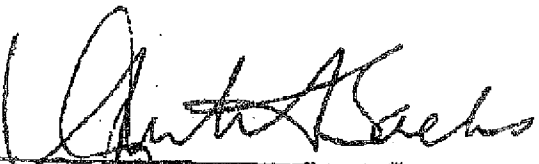
**FURTHER RESOLVED:** That at the Effective Time, this Corporation change its corporate name by changing Article FIRST of its Certificate of Incorporation to read in its entirety as follows:

**"FIRST:** The name of the corporation is Marconi Communications, Inc."

FOURTH: The certificate of incorporation of the Corporation shall be the certificate of incorporation of the surviving corporation in the merger, except that the certificate of incorporation shall be amended so that the name of the surviving corporation thereunder shall be Marconi Communications, Inc."
