This Assignment shall not be construed to cover any copyrights owned or controlled by Carl Steadly.

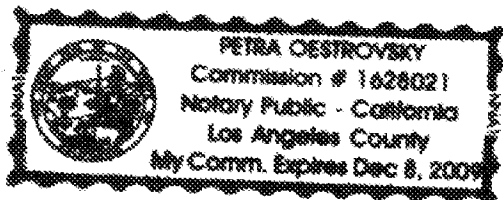
