## TRADEMARK ASSIGNMENT AND COPYRIGHT LICENSE

THIS TRADEMARK ASSIGNMENT AND COPYRIGHT LICENSE ("Trademark Assignment") is dated as of August 19, 2005 by LeGan, Inc., a Delaware corporation, with its principal place of business at 1225 Seventeenth Street, Suite 2440, Denver, Colorado, 80202-5524 ("LeGan") in favor of CSH-INGRE LLC, a Delaware limited liability company (as successor to CSH-ILF LP), with its principal place of business at 100 Milverton Drive, Suite 700, Mississauga, Ontario L5R 4H1 ("CSH-INGRE" and together with LeGan, the "**Parties**," and each individually a "**Party**").

WHEREAS, in furtherance of a certain Purchase Agreement, dated as of \_\_\_\_\_, 2005 (the "Agreement") by and among LeGan and CSH-INGRE, LeGan has agreed to assign to CSH-INGRE all of LeGan's right, title and interest to the trademarks (the "Trademarks") set forth in Exhibit A hereto, and all registrations and applications for registration related to the Trademarks, together with the goodwill associated therewith, and to license certain copyrights in those materials (the "Materials") identified in Exhibit B hereto.

WHEREAS, CSH-INGRE now desires LeGan to execute and deliver to CSH-INGRE this Trademark Assignment required to effect the assignment of the Trademarks and the registrations and applications therefor, and the license of the copyrights to CSH-INGRE in accordance with the Agreement.

NOW THEREFORE, in consideration of the payment of \$10 and good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged:

1. LeGan hereby sells, transfers, conveys, assigns, and sets over unto CSH-INGRE, its successors and assigns, LeGan's entire right, title and interest in and to the Trademarks, including, without limitation, all of LeGan's registrations and applications therefore and CSH-INGRE's right to apply for and register the Trademarks, in the United States of America and all foreign jurisdictions, together with only that goodwill associated with and symbolized by the Trademarks, all common law and statutory rights related to the Trademarks, all rights of renewal and extension, and the right to recover for damages and profits for past infringements thereof by third parties, reserving nothing to LeGan.

2. LeGan hereby grants to CSH-INGRE a fully paid-up, royalty-free, worldwide, perpetual, irrevocable, non-exclusive license to reproduce, publicly distribute, display and perform the Materials, to create derivative works based upon the Materials, to obtain any copyright registrations for or in any such derivative works or any part thereof, and to renew, extend and/or terminate the same in CSH-INGRE's sole discretion and at CSH-INGRE's sole expense. This license shall be freely transferable by Assignee, but only in connection with a sale of the retirement communities identified in the Agreement or to any affiliate of CSH-INGRE in connection with the conduct of business by such affiliate.

3. LeGan represents and warrants that it has not previously made any transfer to any third party of any interest in any of the Trademarks or any application or registration related thereto. Beyond the foregoing warranty of non-hypothecation of the Trademarks, the assignment of Trademarks and copyright license made hereby is "**AS IS**," without representation or warranty of any kind, express or implied, including, without limitation, the **implied warranties of merchantability or fitness for a particular purpose**, non-infringement, non-violation of any person's right of publicity, or that CSH-INGRE will be able to preclude others from using the Trademarks or the Materials, all of which representations and warranties are specifically disclaimed and excluded. In no event shall LeGan or anyone else involved in the creation, production or delivery of the Trademarks or the Materials be liable for loss of savings or profits, direct, indirect, special, incidental, consequential or exemplary damages or loss of goodwill resulting from any defect in the Trademarks and/or Materials, or the use, the results of the use or the inability to use the Trademarks and/or Materials, even if such damages are foreseeable and even if LeGan has been advised of the possibility of such damages or claim. In no event will LeGan's liability for damages to CSH-INGRE or any other person exceed \$100 U.S., regardless of the form of the claim. No employee or agent of LeGan has the authority to modify, extend or add to this Limited Warranty. The above Limited Warranty is the complete and exclusive agreement between CSH-INGRE and LeGan and supersedes all other proposals and prior agreements, oral or written, and any other communications between CSH-INGRE and LeGan or any employee or agent of LeGan relating to the Trademarks and Materials.

4. LeGan shall, upon request by CSH-INGRE, execute, acknowledge and deliver such documents as may be reasonably necessary to convey and assign to CSH-INGRE all of LeGan's right, title, and interest in and to the Trademarks and the applications and registrations therefore consistent with this Trademark Assignment.

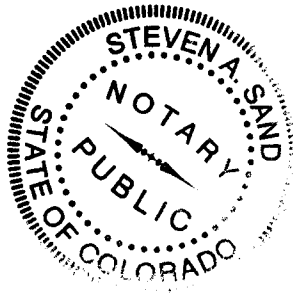
