## CONFIRMATORY ASSIGNMENT OF TRADE-MARKS

WHEREAS, Tradecentrix Pty Limited (formerly Proponix (Australia) Pty Limited. ("Proponix")) was the owner of the trade-marks applied for or registered under the numbers indicated in Schedule A annexed hereto (the "Trade-marks");

AND WHEREAS, American Management Systems, Incorporated was acquired by CGI Group Inc. on May 3<sup>rd</sup> 2004 pursuant to a tender offer and subsequently, on September 9, 2004, changed its name to CGI-AMS Inc.;

NOW THEREFORE, for good and valuable consideration, already received and hereby acknowledged by the parties hereto, Proponix hereby confirms that effective as of March 31, 2003, it did sell, assign and transfer unto AMS, its successors and assigns, all of Proponix's right, title and interest in and to the Trade-marks and the goodwill associated with the Trade-marks, together with all right of action resulting from any adverse use of the Trade-marks or any confusingly similar trade-marks and the right to claim such relief as is appropriate, the same to be held by AMS, its successors and assigns as fully and effectually as they would have been held by Proponix had such sale, assignment and transfer not been made.
