THIS ASSIGNMENT is made by and between MICROTEK MEDICAL HOLDINGS, INC. MICROTEK MEDICAL HOLDINGS, INC. agrees to execute any and all documents necessary to establish title in Assignee, and to record said documents in the United States Patent and Trademark Office.
