**TRADEMARK ASSIGNMENT**

THIS ASSIGNMENT is made the 20th day of December, 2005 by and between **BARBARA B. BRIM, individually** ("Assignor") and **BROWN MANUFACTURING COMPANY, INC.** ("Assignee").

WHEREAS, the Assignor is the Owner of the mark STARR "X" and associated federal registration number 2,333,088 issued on or about November 1, 1949 \* (collectively "The Trademark"); and

WHEREAS, the Assignee wishes to acquire all of Assignor's rights in and to the Trademark and the goodwill associated therewith.

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, including a Promissory Note, the receipt, adequacy and sufficiency of which is hereby acknowledged, Assignor does hereby assign, transfer and convey to the Assignee all of her right, title and interest in and to the Trademark and the registration thereof, together with the goodwill symbolized by the Trademark and the right to sue and recover for damages and profits, and all remedies for past infringements thereof.

The STARR trademark will be assigned to Brown Manufacturing Company by Barbara B. Brim, who will receive a royalty of \$.02 for each STARR bottle opener sold, until her death, after which time no further royalties will be due and owing. Said royalty payment will be paid in December of each year.

Assignor represents and warrants that she is the sole and exclusive owner of the Trademark and that no one else has any rights whatsoever to the Trademark (except for Assignee's licensee rights).

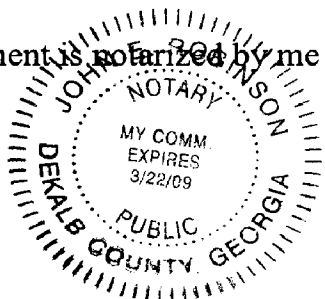
