

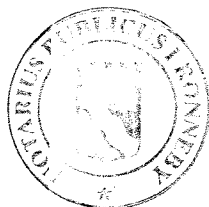

## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is made and entered into by and between

**Arjo Hospital Equipment KB**, Org. No. 969701-1048, a company duly incorporated and organized under the laws of Sweden, having its principal office at Box 61, 241 21 Eslöv, Sweden, (the "Seller"), and

**Arjo Hospital Equipment AB**, Org. No. 556247-0145, a company duly incorporated and organized under the laws of Sweden, having its principal office at Box 61, 241 21 Eslöv, Sweden, (the "Purchaser").

### WHEREAS

- (A) The Seller is the proprietor of the trademarks and trademark applications listed in Schedule A (the "Trademarks").
- (B) The parties have agreed to assign the Seller's rights to the Trademarks to the Seller pursuant to an Asset Transfer Agreement, dated 1 December 2005.

### NOW, THEREFORE, THE PARTIES AGREE AS FOLLOWS:

- 1.1 The Seller hereby assigns to the Purchaser all right, title and interest in and to the Trademarks.
- 1.2 The assignment of the rights in Section 1.1 is complete and includes without limitation all income, royalties, damages and payments now and hereafter due/or payable with respect to the Trademarks (including, without limitation, damages and payments for past or future infringements or misappropriations thereof). The Purchaser may in its sole discretion transfer, licence or otherwise dispose of all or any part of the rights assigned hereunder.
- 1.3 The Seller undertakes to execute and deliver, at any time upon request, free of charge, any and all documents, forms and authorizations necessary for the registration of the assignment of the Trademarks with the relevant registration authorities (in all countries concerned), and to provide all other reasonable assistance, free of charge, requested by the Purchaser in order to perfect the Purchaser's title to the Trademarks.
- 1.4 The Seller hereby agrees that the Purchaser may take the trademark recordal procedure in the sole name of the Purchaser.
- 1.5 The Purchaser accepts the assignment and shall pay all fees charged by the registration authorities in connection with the registration of the assignment of the Trademarks.
