Pursuant to the Articles of Incorporation (the "Articles") and RCW 23B.10 of the Washington Business Corporations Act, the shareholders of Mforma Group, Inc., UBI# 602229667 (the "Corporation"), as required by the Articles, have approved an amendment to the Articles to effect the change of the name of the Corporation.

1. The name of the Corporation is Mforma Group, Inc.;
2. Article 1 of the Articles is hereby amended in its entirety to read as follows:

3. The amendment does not provide for an exchange, reclassification or cancellation of issued shares.
