**ARTICLES OF AMENDMENT  
OF THE ARTICLES OF INCORPORATION  
OF VISTA:CAPE TECHNOLOGY CORP.**

1.

The name of the Corporation is VistaScape Technology Corp. (the "Corporation").

2.

Effective as of the date hereof, Article I of the Articles of Incorporation of the Corporation shall be amended by deleting Article I in its entirety and substituting in lieu thereof the following: The name of the corporation is "VistaScape Security Systems Corp." The Corporation hereby amends Article II of its Articles of Incorporation by replacing the Certificate of Designations of Preferences, Limitations, and Relative Rights of Series A Convertible Preferred Stock, Series B Convertible Preferred Stock, Series C-1 Convertible Preferred Stock and Series C-2 Convertible Preferred Stock of VistaScape Technology Corp. in its entirety with the Designations of Preferences, Limitations, and Relative Rights of Series A Convertible Preferred Stock, Series B Convertible Preferred Stock, Series C-1 Convertible Preferred Stock and Series C-2 Convertible Preferred Stock of VistaScape Security Systems Corp. as set forth on Exhibit A attached hereto.

Said amendments were adopted by the Board of Directors of the Corporation as of February 19, 2003.

Said amendments were duly adopted by shareholder action in accordance with Sections 14-2-1003, 14-2-1004 and 14-2-704 of the Georgia Business Corporation Code.
