TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Assignment") is to be effective as of April 29, 2005, and is entered into by and among ACMI Corporation, a Delaware corporation, ("Assignor"), and ProstaLund Operations AB, a Swedish company, ("Assignee").

WHEREAS, Assignor, having its principal offices at 136 Turnpike Road, Suite 300, Southborough, MA 01772, the United States of America, is the owner of the CORETHERM trademark and the associated registration(s) and/or application(s) for registration thereof listed on Exhibit A attached hereto (collectively, the "Mark").


WHEREAS, Assignee, having its principal offices at Hstbruksvgen 10, SE-226 60 Lund, Sweden, is desirous of acquiring all worldwide right, title and interest in and to said Mark as part of the Settlement Agreement between Assignor and Assignee, dated April 29, 2005 (the "Settlement Agreement").

NOW THEREFORE, be it known that for the consideration set forth in the Settlement Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all of Assignor's worldwide right, title and interest in and to said Mark, together with the goodwill of the business symbolized by said Mark, any future registrations of said Mark, and all common law rights associated with said Mark, and any and all causes of action and other rights assertable under said Mark, the right to sue third parties for infringement of or improper activities regarding said Mark, and the right to enjoy all of the monetary benefits obtained as a result of any such litigation, the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

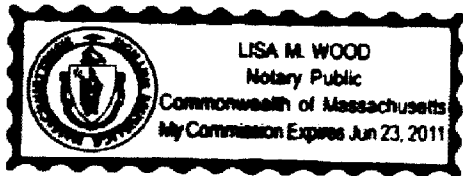
