## TRADEMARK RELEASE

THIS TRADEMARK RELEASE ("Release") is given as of this 26<sup>th</sup> day of April, 2006 by Wachovia Bank, National Association ("Assignor"), to AeroTurbine, Inc. ("Assignee") as follows:

WHEREAS, Assignor and Assignee entered into a Security Agreement, dated as of December 29, 2003 (the "Security Agreement") which was recorded in the United States Patent and Trademark Office on March 4, 2004 at Reel/Frame 002804/0271 to Reel/Frame 002804/0275, pursuant to which Assignee granted to Assignor a security interest in the trademark, AEROTURBINE (U.S. registration number 2260554; registration date 07/13/99) (the "Trademark"), as collateral security for the prompt payment and performance in full when due, whether by lapse of time, acceleration, mandatory prepayment or otherwise, of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, pursuant and subject to that certain Payoff Letter, dated as of April 26, 2006, Assignor has agreed to release its existing security interest in the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby unconditionally, irrevocably and absolutely releases, terminates, extinguishes and forever discharges its security interest in the Trademark and reassigns any and all interest Assignor may have in the Trademark to the Assignee. This Release shall be binding upon Assignor's legal representatives, assigns and successors. The Parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademark
