CERTIFICATE OF INCORPORATION
OF

SOUTH BROOKLYN CASSET CO., INC.

Pursuant to Article II of the Stock Corporation Law.

WE, the undersigned, for the purpose of forming a corporation pursuant to Article II of the Stock Corporation Law of the State of New York, certify:

1. The corporate name of said corporation shall be SOUTH BROOKLYN CASSET CO., INC.

2. The purposes for which the said corporation is to be formed are as follows:

To manufacture, buy, sell, import, export, and generally deal in burial caskets of all kinds and of whatever material made, trimmings for caskets, linings, rough boxes, plates, hearses, embalming fluid, and other chemicals or drugs used by undertakers and all tools and appliances and devices used and required by undertakers, and any and all other supplies to acquire all real estate and plant or plants necessary to carry out the above object; to borrow money and give notes therefore or other evidence of indebtedness necessary to carry on the business of the company.

3. The amount of the capital stock of said corporation shall be Fifteen thousand (\$15000.00) Dollars, and shall consist of One hundred and Fifty (150) shares of common stock of the par value of One hundred (\$100.00) Dollars.

4. The location of the office of the said corporation shall be in the Borough of Brooklyn, County of Kings, City and State of New York.

5. The duration of the said corporation shall be perpetual.

6. The number of directors of the corporation shall be three.
