CONFIRMATION

DYNO INDUSTRIER AS, organization number 820 051 122, was transferred to the Register of Business Enterprises on 5 November 1988.

Changes in the Norwegian Companies Act, dated 4 June 1976, no. 59, and the Norwegian Act regarding the exclusive Right to Business Names and Other Business Distinguishing Characteristics (The Distinguishing Characteristics Act) dated 21 June 1985, no. 79 resulted in changes in the name and type of business of **DYNO INDUSTRIER ASA**, organization number 820 051 122.

The EEA agreement required that the Norwegian Companies Act had to be brought into line with the EU's company legislation regulations by 1 January 1996.

Pursuant to the EU's regulations it was agreed to introduce a fundamental distinction between a Limited Company and a Public Limited Company, cf. The Norwegian Companies Act § 1-1 subsection 3.

DYNO INDUSTRIER ASA is a Public Limited Company. The name of a Public Limited Company must contain the words Public Limited Company or the abbreviation ASA.

The changes came into force on 1 January 1996.

The change in the legislation resulted in changes in information registered about **DYNO INDUSTRIER ASA** in the Register of Business Enterprises.

1. The name was changed from **DYNO INDUSTRIER AS** to **DYNO INDUSTRIER ASA**.
2. The company changed from being a Limited Company to being a Public Limited Company.

These changes were registered in the Register of Business Enterprises on 20 January 1996.

In the notification registered in the Register of Business Enterprises on 12 March 2001 the following change regarding the name was registered:

Name: **DYNEA ASA**

In the notification registered in the Register of Business Enterprises on 17 September the company converted from being a Limited Company to a Public Limited Company. In accordance with this the name of the company was changed from **DYNEA ASA** to **DYNEA AS**.


In the notification registered in the Register of Business Enterprises on 28 September 2005 **DYNEA AS** was dissolved for merger with **NORDKEM AS**, organization number 981 313 054.

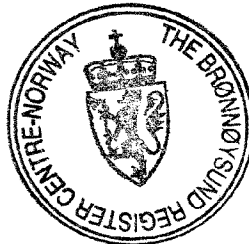
As a result of the merger, notification was given that **DYNEA AS**, organization number 820 051 122 was struck off the Register of Business Enterprises on 1 December 2005.


In the notification registered in the Register of Business Enterprises on 1 December 2005 **NORDKEM AS**, organization number 981 313 054 changed the name to **DYNEA AS**.

After this date no changes have been registered in the Register of Business Enterprises regarding the name.
