
RELEASE OF TRADEMARK SECURITY AGREEMENT

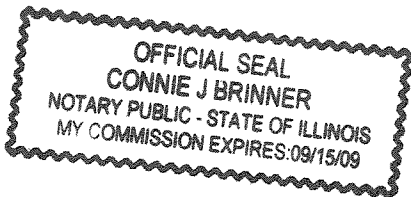
