TRADEMARK ASSIGNMENT

WHEREAS, Bright Solutions, Inc., a Florida Corporation having an address at 4680 N. NOW, THEREFORE, in consideration for ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, transfer and convey to Assignee all of Assignor's right, title, and interest in and to the Marks, the Pending Applications, and the goodwill of Assignor's business symbolized by the Marks or with which the Marks were intended to be used, including the right to sue for damages for all past infringement occurring prior to the execution date of this Assignment, and to any and all marks and registrations which may evolve therefrom.

Assignor also assigns to Assignee all of its right, title and interest in and to the Marks in all foreign countries, and all applications for registration of the Marks in foreign countries and any registration(s) which may evolve therefrom, including the right to claim International Convention priority.

Assignor agrees to execute any papers or perform any acts required to establish, vest or protect Assignee's rights herein or which may be reasonably requested by Assignee to effectuate the purpose of this Assignment, without any additional payment therefor, but without any expense to Assignor.
