- B. Assignor is the parent company of Waterbury Headers Corporation, the assets of which were acquired by WH, LLC on July 17, 2003. While such acquisition included the above-referenced trademark, no formal Assignment of Trademarks was ever recorded
- C. WH, LLC is a shareholder of FS Manufacturing, Inc., which has sold its Waterbury product line to Assignee.
- D. In order to assist FS Manufacturing, Inc. in completing the sale of its Waterbury product line to Assignee, Assignor has agreed to assign the above-referenced trademark to Assignee.

## AGREEMENTS:




