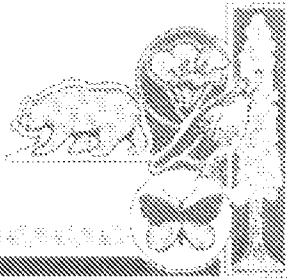

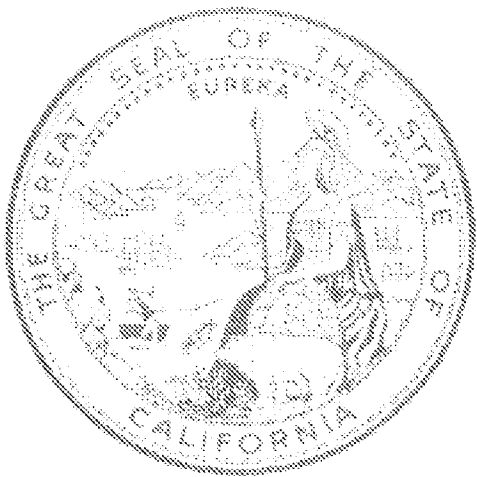

2. Article 1 of the articles of incorporation of this corporation is amended to read as follows:


The name of this corporation is:
