ASSET PURCHASE AGREEMENT

THIS ASSET PURCHASE AGREEMENT (this "Agreement") is entered into as of the effective date set forth below by and between (i) AdMission, Inc., a Delaware corporation (the "Buyer") and (ii) IPIX Corporation, a Delaware corporation (the "Seller"). The Buyer and the Seller are referred to herein individually as a "Party" and collectively as the "Parties." The capitalized terms used herein and not otherwise defined have the meanings given to such terms as set forth in Appendix A hereto.

WHEREAS, the Seller, through its three business units, IPIX Security, IPIX AdMission and IPIX InfoMedia, provides solutions for the creation, processing and management of media, including still images, Full-360 degree immersive images and video;

WHEREAS, the AdMission division of the Seller currently offers services that visually enhance advertisements for directional advertising publishers and other media sharing applications (the "AdMission Business");

WHEREAS, the Buyer desires to purchase, and the Seller desires to sell, on the terms and conditions set forth herein, the assets and contracts constituting the AdMission Business in exchange for the consideration described below;

WHEREAS, the Seller desires to retain and continue to operate its IPIX Security and IPIX InfoMedia divisions;

WHEREAS, the Buyer will provide the Seller with a license to certain patent rights included in the AdMission Business which are required to continue to operate and develop the IPIX Security and IPIX InfoMedia business units; and

WHEREAS, the respective Board of Directors of each of the Seller and the Buyer has approved this transaction;

NOW, THEREFORE, in consideration of the foregoing, of the mutual promises herein contained and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending legally to be bound, hereby agree as follows:

ARTICLE I PURCHASE AND SALE OF PURCHASED ASSETS

1.1. Purchased Assets. On the terms and subject to the conditions of this Agreement, the Seller hereby agrees to sell, convey, assign, transfer and deliver to the Buyer and the Buyer hereby agrees to purchase, accept and take from the Seller, all of the Seller's right, title and interest in the following (the "Purchased Assets");

(a) The following items (the "AdMission Products");

(i) the trademarks, trade names, service marks, domain names and business brands set forth on Schedule 1.1(a)(i) and the goodwill associated therewith;
